

The following decisions regarding Covid-19 guidelines were agreed upon at the June 23, 2021 Village IV Board of Directors meeting after receiving updated guidelines from the DuPage County Health Department:

#### MASK POLICY IN BUILDING

Masks are no longer required if you have been fully vaccinated.

*Please continue to wear a mask if you are not vaccinated.*



#### SWIMMING POOL RESERVATIONS

Effective June 24, 2021, advance reservations are no longer required when utilizing the swimming pool!

There are **no capacity limits at the pool**. Guests are allowed according to the member's card color (up to 2 guests for blue cardholders, 1 guest per orange and yellow cardholders).

No need to register at the office for a wristband :)

Bring your membership card to the pool and check-in at the lifeguard stand as in pre-covid times!

We ask that every family (including guests) have a signed Covid-19 Waiver of Liability on file for the season. Forms are available at the pool.

Please be mindful of the current social distance guideline of 3 feet between members of unrelated households.



#### PRIVATE POOL PARTIES

We will return to our pre-covid policy of allowing private parties in the pit area (up to 50 people) on Mondays—Thursdays, 5:00 PM—8:00 PM.

#### SAUNAS

The Men's and Women's saunas will be available for use after thorough sanitizing is complete.

#### WEIGHT ROOM RESERVATIONS

The Weight Room Covid reservation policy remains unchanged. We continue limiting use to one person at a time by reservation only with a one-hour limit.

2 users from the same household are permitted.

#### PARTY ROOM CAPACITY

The Covid capacity limits have been eliminated. Party Room capacity is now at the (pre-covid) maximum of 100.



#### CLUBHOUSE HOURS

**Effective July 1, 2021**, the weekday Clubhouse hours will return to pre-Covid schedule, **Monday—Friday, 9:00 AM—9:00 PM.**
